V Student Concerns/Questions/Announcements

- Complaint: ... no pizza at senate meetings...
 - O Today will be that l;ast meeting where pizza complaints will be addressed. Last year the pizza that was provided at the senate meetings was a privilege and not something that the SGA is required to provide. Unfortunately there is not enough funds to provide pizza at all of the SGA meetings anymore.
- Complaint: ...movie service issues...
 - Currently, the movie service NMT provides in the middle of updating its contracts with the movie service, which might be causing some of the problems.
- Complaint: "When are they actually going to finish the construction work on south? It has been weeks now and there is no one working on it. The school has just gated off the parking lot and nothing has happened. It is so frustrating to me as someone who is having to deal with the inconvenience everyday. Epically when there is no further progress in the actual project"
 - This complaint has been brought up before and the initial plan was to ask Reslife about an expected timeline to inform students about the construction process, but the SGA has not heard back from Reslife.
 - Dean Chapman states that due to some unforeseen circumstances the construction is on hold because there have been some insurance problems that are halting the progress of the building construction.
- Question: "...just wondering if we are gonna have Dirt for the 49ers, last year we didn't have it. Would be cool if we get it"
 - Historically, Dirt did not normally come out during 49ers. It has been some time since Dirt was published during 49ers. Unfortunately the Paydirt team will not be publishing Dirt during 49ers, but Dirt will be coming out during dead week like normal.

- Concern: "the handicap doors don't always work and i have heard that tech turns them off to 'save power'"
 - It is true that the handicap doors can be unreliable sometimes; the appropriate channels will be informed about the issue.
- Comment: "Y'all don't need free pizza"

 - The Chief Justice really appreciated the compliments :)
- Complaint: "The Health Center is not helpful to students, and is dismissive of students' concerns. My shoulder was injured playing basketball. There was intense, sharp pain and I heard a crunch when it happened. That night, I could barely move my arm and I was in the worst pain I have ever felt. The next morning I went to the health center. I explained the injury, pain level, and how I couldn't use my arm at all. After barely examining my shoulder, they told me I needed to ice and rest it and it might hurt for a couple weeks. It felt like they didn't take my injury seriously, and were acting like it wasn't any more serious than soreness or a bruise. Having played basketball for many years, I know the difference between a real injury and something that will get better with ice and rest. Since then, I've had to go to a doctor in Albuquerque to get x-rays and an MRI. I have a chipped bone and a torn labrum that will require surgery. Because the health center didn't take me seriously, I've had to miss classes and make multiple long trips to Albuquerque that I otherwise wouldn't have made. I feel like NMT should be able to help students with serious health issues, or at least tell them they need outside help and not dismiss students' pain. Not only did they not help, the way they talked to me made it seem like they thought I was exaggerating. (This is also not the first time I've had a negative experience with the health center.)"
 - The health of the students is something the SGA takes really seriously, this issue will be looked into.
 - Some options proposed by the Senate:
 - Set up a complaints form for the health center
 - Conduct a review for the health center programs and protocols
 - Reevaluate the training the health center receives
 - Update the health center website that provided more information to the students.
 - Speak to Peter Phaiah about issues that arise from health center visits.
- Complaint: "If I have to sit through one more senate meeting of someone acting like a child on these forms complaining about pizza I will lose it. If pizza is the only reason you are here join a club. Many of them offer pizza. It wastes all of our time. Please grow up. It isn't the SGAs job to feed us"
